Invitation to Bid for the Proposed Construction of Standard Municipal Police Station Building Type "B/C" at Alubijid, Misamis Oriental

1. The **POLICE REGIONAL OFFICE 10**, through the PNP Trust Receipts for 1st Quarter CY 2017 and LGU Counterpart intends to apply the sum of **Five Million One Hundred Seventeen Thousand Seven Hundred Pesos (Php5,117,700.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Standard Municipal Police Station Building Type "B/C" at Alubijid, Misamis Oriental**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Police Regional Office 10 now invites bids for the Construction of Standard Municipal Police Station Building Type "B/C" at Alubijid, Misamis Oriental. Completion of the Works is required **255 Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Police Regional Office 10 and inspect the Bidding Documents at the address given below from *Monday to Friday, 8:00 AM – 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on **September 14 - 21, 2017** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php10,000.00)**.
6. The Police Regional Office 10 will hold a **Pre-Bid Conference on September 22, 2017 (Friday), 2:00 PM** at *RHQ Conference Room, Camp 1Lt Vicente G Alagar, Cagayan de Oro City*, which shall be opened to prospective bidders.


7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 4, 2017 at 1:00 PM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **October 4, 2017, 1:01 PM** at *RHQ Conference Room, Camp 1Lt Vicente G Alagar, Cagayan de Oro City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Police Regional Office 10 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
