Bidding will be conducted through Rule XVI – Alternative Method of Procurement under Section 53 – Negotiated Procurement – Two Failed Biddings, pursuant to Revised Implementing Rules and Regulations (IRR) of RA No. 9184, whereby the Procuring Entity directly negotiates a contract with

technically, legally and financially capable contractor in case of two failed biddings.

To bid for this contract, the prospective bidders/suppliers are required to submit their Eligibility & Technical and Financial components of its bids (one (1) ORIGINAL and two (2) copies) and the Original Receipt (OR) for payment of bidding documents before dropping of bids on the specified schedule.

Please be reminded that the GPPB issued Circular No. 07-2017 dated July 31, 2017 entitled “Deferment of the Implementation of the Mandatory Submission of PHILGEPS Certificate of Registration and Membership” hence, prospective bidders are required to submit the following Class “A” eligibility documents under Sections 23.1(a) and 24.1(a) of the IRR of RA No. 9184, to wit:

- a. Registration Certificate;
- b. Mayor’s/Business Permit or its equivalent document;
- c. Tax Clearance; and
- d. Audited Financial Statements.

In lieu of the above documents, prospective may still submit their PhilGeps Platinum Certificate of Registration and Membership at their option.

A complete set of Bidding Documents may be purchased from the RLRDD Office, RHQ Admin Building, Camp 1Lt Vicente G Alagar, Lapasan, Cagayan de Oro City upon payment of a non-refundable fee for the Bidding Documents in the amount stated above.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Contractor who will submit the Lowest Financial Proposal will be considered and recommended for Bid Evaluation and Post Qualification. If found complying, said supplier will be recommended to the Head of Procuring Entity for the issuance of Notice of Award.

Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address above. Late bids shall not be accepted.

The Police Regional Office 10 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without

thereby incurring any liability to the affected bidder or bidders. Your prompt reply on the matter is highly appreciated.
