## **Invitation to Bid for the Proposed Procurement of 1 Lot Various Repair/Renovation Projects Inside Camp Alagar, Lapasan Cagayan De Oro City**

1. The **POLICE REGIONAL OFFICE 10**, through the Capability Enhancement Program (CEP) 2016 and 2017<sup>1</sup> intends to apply the sum of **One Million Seven Hundred Seventy Nine Thousand Four Hundred Forty Two Pesos and 78/100 (Php1,779,442.78)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of 1 Lot Various Repair/Renovation Projects Inside Camp Alagar, Lapasan Cagayan De Oro City**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Police Regional Office 10 now invites bids for Procurement of 1 Lot Various Repair/Renovation Projects Inside Camp Alagar, Lapasan Cagayan De Oro City.<sup>2</sup> Completion of the Works is required **120 Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from Police Regional Office 10 and inspect the Bidding Documents at the address given below from *Monday to Friday, 8:00 AM – 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested bidders on **December 12, 2017 – January 11, 2018** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php5,000.00)**.

6. The Police Regional Office 10 will hold a **Pre-Bid Conference<sup>3</sup>** on **December 19, 2017 (Tuesday), 10:00 AM** at *RHQ Conference Room, Camp 1Lt Vicente G Alagar, Cagayan de Oro City*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before January 11, 2018 at 2:00PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

**Bid opening** shall be on **January 11, 2018, 2:01 PM** at *RHQ Conference Room, Camp 1Lt Vicente G Alagar, Cagayan de Oro City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Police Regional Office 10 reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
