Supply and Delivery of 1 Lot Fuel, Oil, and Lubricants (FOL) through NEP 2023 Public Bidding No. PRO 10-PB-G-2023-01

Issued pursuant to Sec. 22.5 of the IRR OF RA 9184 to clarify and/or amend certain provisions in the Bidding Documents issued for the project, considering the clarifications made by prospective bidders through bidder's written queries received within the prescriptive period for filing.

POLICE REGIONAL OFFICE 10, through the Bids and Awards Committee (BAC) issued this Bid Bulletin to amend portions of the bidding documents in connection with the **Supply and Delivery of 1 Lot Fuel, Oil, and Lubricants (FOL) through NEP 2023** as follows:

I. AMMENDMENTS/CLARIFICATIONS

Section III. Bid Data Sheet. Clause 15. Bidders shall submit one (1) ORIGINAL and one (1) COPY of the FIRST and SECOND components of its bid.	The bidder is reminded that they shall submit one (1) "ORIGINAL" and one (1) "COPY" of the FIRST and SECOND components of its bid. However, bidders may be allowed to faithfully reproduce or photocopy the originally signed documents as "COPY" provided that the originally signed documents are provided in the "ORIGINAL".
Section VI. Schedule of Requirements under item 1. Delivery Period: The Supplier shall deliver the items subject of this Supply Contract in Drums, Bulk or other packaging without need of Demand, with the following respective lead times: (a) 24-hours from the time of order within Cagayan de Oro City; and 48-hours from the time of order to other locations.	Section VI. Schedule of Requirements under item 1 Delivery Period shall be changed to: The Supplier shall deliver the items subject of this Supply Contract in bulk without need of demand with the following respective lead times: (a) 24-hours from the time of order within Cagayan de Oro.
