The BAC will conduct Alternative Mode of procurement through Negotiated Procurement under **SMALL VALUE PROCUREMENT**, Rule XVI, Section 53.9 of the IRR of RA 9184.

To be eligible to bid for this contract, a contractor must meet the following major requirements: (a) Duly licensed Filipino citizen/sole proprietorship (b) Partnerships duly organized under the laws of the Philippines and which at least sixty percent (60%) of the interest belongs to citizen of the Philippines; (c) Corporation duly organized under the Philippines, and which at least sixty percent (60%) of the outstanding capital stock belongs to citizens of the Philippines.

The prospective bidder must have completed, within the period specified, an SLCC that is similar to the contract to be bid, and whose value must be at least fifty percent (50%) of the ABC and the Net Financial Contracting Capacity (NFCC) at least equal to ABC.

The BAC will request all invited/interested bidders to submit the best offer based on the technical and financial requirements not later than **September 23, 2022, 10:00 AM**.
